- to use any collected information and documents exclusively for the purposes of reviewing of projects in the in the area of grant support of the National Research Foundation of Ukraine, to provide security and protection of the information and documents due to technical capacity of available means;
- to comply with the requirements of regulations on the legal status of personal data, sensitive information, scientific and technical information;

- to refrain from using any information and documents that have become available while performing my responsibilities on conducting reviewing of projects to carry out any activities, including activities negatively affecting the National Research Foundation of Ukraine;

**- to immediately notify the chief of the review panel of the Call Commission, the Head of the National Research Foundation of Ukraine (for other persons involved in the competitive selection and project review) of loss of data storage devices (magnetic and paper, including manuscripts, drafts, drawings, etc., video and photo materials, models, products, etc.), and of other circumstances that may lead to disclosure of information protected by law, as well as the reasons and conditions of such facts;**

- to secure confidentiality of previously reviewed projects, except as provided by law;

**- in case of termination of cooperation with the National Research Foundation of Ukraine (whatever the reasons for such termination) to transmit to the chief of the review panel of the Call Commission, the Head of the National Research Foundation of Ukraine (for other persons involved in the competitive selection and project review) within the period of three days after the decision to terminate cooperation all data storage devices (magnetic and paper, including manuscripts, drafts, drawings, etc., video and photo materials, models, products, etc.) that have become available in connection with the performance of my responsibilities.**
